LIMITED REVIEW REPORT

To
The Board of Directors,
N. E. Electronics Limited

We have reviewed the unaudited financial results of N. E. Electronics Limited ("the Company"), for the quarter ended December 31, 2020 together with the notes thereon (the "Statement").
